- **Repurchase Offer Record Date:** Date a shareholder must own shares to participate in the quarterly repurchase offering.
- **Repurchase Request Withdrawal Deadline:** Date by which all written shareholder repurchase requests must be withdrawn.
- **NAV Determination Date:** Date the NAV applicable to the share repurchase will be determined.
- **Repurchase Payment Deadline:** Date for the Fund to deliver repurchase proceeds for the repurchase offering.
